

Defibrillator Giveaway – Terms & Conditions

1. Promoter

The promoter of this giveaway is Your First Aid Team (ABN: 53980208959), located in Victoria, Australia (“Promoter”).

2. Promotion Period

The promotion opens at 7am, 24 February 2026 and closes at 5pm, 31 March 2026 (“Promotion Period”).

Entries received after this time will not be accepted.

3. Eligibility

Entry is open to organisations located in Victoria, Australia.

The following are not eligible to enter:

- Individuals entering in a personal capacity
- Employees of the Promoter and their immediate families

Only one entry per organisation is permitted.

4. How to Enter

Entry is free.

To enter, eligible organisations must:

1. Complete entry form and
2. Answer the skill-based question:

“Why does your workplace need a defibrillator?”

5. Game of Skill

This promotion is a game of skill, not a game of chance.

Entries will be judged based on:

- Demonstrated need for a defibrillator
- Potential impact on workplace or community safety
- Quality and relevance of the response

Chance plays no part in determining the winner.

6. Judging

Judging will take place on or around 7 April 2026 by a panel appointed by the Promoter.

The judges’ decision is final, and no correspondence will be entered into.

7. The Prizes

One (1) winning organisation will receive:

- One (1) Automated External Defibrillator (AED) – Valued at \$2,200 AUD
- Defibrillator Training for up to 20 participants, delivered on-site in Victoria – Valued at \$1,800 AUD
- Cabinet and Installation \$550

Total Prize Value: \$4,550 AUD

Referral Bonus Prize: Vehicle First Aid Kit – Valued at \$150 AUD

8. Prize Conditions

- The AED model supplied may vary slightly depending on availability but will be of equal or greater value
- Training must be redeemed within 3 months of the winner being notified
- Training is delivered during standard business hours unless otherwise agreed
- The prize is not transferable, refundable, or redeemable for cash
